Before You Begin

Navigating the Notice of Funding Opportunity

To reduce the burden on applicants in the Notice of Funding Opportunity (NOFO) process and limit the length of the NOFO information requests, we separated the NOFO into two parts.

The NOFO Part 1 describes the DOE program goals and evaluation criteria, eligibility, and other components specific to each funding opportunity. NOFO Part 2 includes the fixed DOE requirements that generally do not change from NOFO to NOFO, including standard information for the application phase, expectations for award negotiations, and post-award requirements. You must review both parts before applying. To assist you in the process, you will find references throughout this document to additional information in Part 2.

You must also take several one-time actions before applying. Some of these actions may take several weeks, so be sure to allow yourself enough time to complete them. If you don't complete all required steps, it could interfere with application and negotiation deadlines or the ability to receive an award if selected. If you already completed these one-time registrations, make sure they are active and up to date. All registrations are free. You can find additional information about registration in [NOFO Part 2, Required Registrations](#).

Hyperlinks are provided for the applicant's ease of reference. Links, and the information contained in them, may change over time. It is up to an individual applicant to make sure that they have the current information that is contained in the links.

II. Eligibility

To be considered, your submission must meet the criteria set forth below. If your application does not meet these eligibility requirements, it will be removed from consideration for any award. DOE will not determine eligibility for potential applicants before the application due date. The information in this document is specific to this NOFO. You can find the eligibility requirements that apply to all NOFOs in [NOFO Part 2, Eligibility](#).

A. Eligible Applicants

The scope of work to be performed by subrecipients may not be more significant than the scope of work to be performed by the applicant.

1. Restricted Eligibility

DOE restricted eligibility for this NOFO per 2 CFR § 910.126, Competition, including writing a Determination for Restricted Eligibility

Eligibility for this NOFO is restricted because the financial assistance awards under the UTR program's topic areas are intended to maintain and upgrade the educational, training, and research capabilities of institutions of higher education (IHEs) in the fields of science, environment, energy, and technology related to coal, oil, natural gas, and geothermal energy. DOE is restricting eligibility to the entities identified below.

This NOFO was developed using funding appropriated for the UTR program; therefore, soliciting proposals on a restricted eligibility basis is necessary and appropriate. This determination is valid for five (5) years.

Eligibility as prime recipient will be restricted to United States (U.S.) IHEs. Other entities may partner with prime institutions. Although Federally Funded Research and Development Center (FFRDC¹) contractors are not eligible for an award as a prime, they may be proposed as a team member as long as, in aggregate, their effort does not exceed 25% of the total estimated cost of the project, including the applicant's and the FFRDC contractor's portions of the effort. NETL may not participate as a project team member or subrecipient.

A portion of appropriated funds may be allocated further to Historically Black Colleges and Universities (HBCUs), Tribal Colleges and Universities (TCUs), and Hispanic-Serving Institutions (HSIs).² This allocation is in accordance with section 1105 of the Energy Policy Act of 2005, which amended the Department of Energy Science Education Enhancement Act (42 U.S.C. § 7381) and is in alignment with the White House Initiative to Promote Excellence and Innovation at HBCUs (Executive Order 14283) by improving the competitiveness of HBCUs for federal R&D funding.

To ensure the UTR program continues to support the performance of high-quality fundamental research by professors and students at U.S. IHEs, applications must adhere to the following additional criteria:

- The Principal Investigator (PI) or co-PI listed on the application is a professor at the submitting IHE. If this condition is met, other participants, co-PIs, or research staff that do not hold teaching or student positions may be included as part of the research team.
- At least one student registered at that university is to receive compensation for work performed for the proposed research.

- If the funds are allocated to an HBCU, TCU, or HSI, the PI and the co-PI listed on the application are professors at the respective IHE.
- Proposals from university-affiliated research institutions must be submitted through the college or university with which they are affiliated.

See Section IV of the NOFO for further details on application contents required to qualify under this restricted eligibility.

2. Domestic Entities

Domestic entities are eligible to apply (refer to Section II.A.1 for additional eligibility restrictions). The following types of domestic entities are eligible to participate as part of this NOFO:

As recipients or subrecipients:

- Institutions of higher education including technical/trade schools (as defined in [Title 20 U.S.C. § 1001](#)).

As subrecipients only:

- For-profit organizations
- Nonprofit organizations
- State and local government entities
- Indian Tribes (as defined in section 4 of the Indian Self-Determination and Education Assistance Act, 25 U.S.C. § 5304)³

To qualify as a domestic entity, the entity must be legally formed in the U.S. and have a physical location for business operations in the U.S.

Participant Limitations

Participation of the following entities is limited as follows.

- Provided there is no conflict, DOE FFRDCs¹ are eligible to apply for funding as a subrecipient (except for NETL) but are not eligible to apply as a recipient
- Non-DOE FFRDCs are eligible to participate as a subrecipient but are not eligible to apply as a recipient
- Federal agencies and instrumentalities (other than DOE) are eligible to participate as a subrecipient but are typically not eligible to apply as a recipient
- NETL is not eligible for award under this announcement and may not be proposed as a subrecipient on another entity's application. An application that includes NETL as a recipient or subrecipient will be considered non-responsive.

3. Foreign Entity Participation

In general, foreign entities are not eligible to apply as either a recipient or subrecipient. In limited circumstances, we may approve a waiver to allow a foreign entity to participate as a recipient or subrecipient.

A foreign entity may apply to this NOFO, but the application must be accompanied by an explicit written waiver request. Likewise, if you want to include a foreign entity as a subrecipient, you must submit a separate explicit written waiver request in your application for each proposed foreign subrecipient. *NOFO Part 2, Application Content Requirements*, explains the requirements for submitting a foreign entity waiver request. DOE's determination of a waiver request is final and you cannot appeal an adverse decision on a waiver request.

4. Performance of Work in the United States

All work for the awards under this NOFO must be performed in the U.S. To request a waiver of this requirement, you must submit an explicit waiver request in the application. Without an approved waiver, such costs will not be allowed under the award. *NOFO Part 2, Application Content Requirements*, lists the requirements for submitting a foreign work waiver request.

5. Ineligible Participants

The following entities are ineligible for this NOFO as a recipient, subrecipient, or subcontractor:

- In accordance with 2 C.F.R § 200.214, entities banned from doing business with the U.S. Government, such as entities debarred, suspended, or otherwise excluded from or ineligible for participating in Federal programs (2 C.F.R § 200.214)
- Entities identified on the Department of the Treasury Office of Foreign Assets Control Treasury's Sanctions Program Specially Designated Nationals list. ([OFAC—Sanctions List Service \[treas.gov\]](#))
- Nonprofit organizations described in section 501(c)(4) of the Internal Revenue Code of 1986 that engaged in lobbying activities after December 31, 1995

Entity of Concern Prohibition

Entities of Concern are prohibited from participating in projects under this NOFO. You can find details and definitions in *NOFO Part 2, Eligibility, Other Eligibility Information, Entity of Concern Prohibition*.

B. Limitation on Applications Eligible for Review

You can submit more than one application to this NOFO, provided that each application describes a unique, scientifically distinct project as determined by DOE.

C. Cost Sharing

You must follow through on the estimated cost share commitments you proposed in your application if selected for award negotiations. You can find more information on cost sharing in *NOFO Part 2, Eligibility*.

1. Cost Share Requirements

Cost sharing is not required under this NOFO for prime or subrecipients. However, applicants can propose voluntary industrial collaboration cost share, which may include the following:

1. Cash cost-sharing received by the university awardee from participant(s)
2. Subcontracting by university awardee with the industrial participant(s) to provide consultation and experimental data and/or equipment not available at the university
3. In-kind collaboration with the industrial participant(s) agreeing to consult with the Principal Investigator and to share non-proprietary information that will assist in improving the experimental plan and/or assist in analyzing data obtained by the Principal Investigator. In-kind use of industrial experimental facilities not available at the university is included in this kind of collaboration

DOE understands that projects selected under this NOFO may require the use of existing data. For purposes of this NOFO, the Contracting Officer will consider the fact that data is available at an established market price when making the cost allowability decision.

To assist applicants in calculating proper cost share amounts, DOE has included additional cost share information and sample cost share calculations in the **NOFO Part 2, Eligibility—Cost Sharing, Cost Share Calculation Examples**.

2. Unallowable Cost Share Sources, NOFO Specific

The recipient or subrecipients may not use the following sources to meet cost share obligations including but not limited to:

- Cost share derived from Federal sources (unless otherwise authorized by law).
- Cost share that does not meet:
 - Requirements set forth in 2 C.F.R. §§ 200.306 and 910.130
 - Cost principles set forth in 2 C.F.R. §§ 200.400-476 and 2 C.F.R. § 910.352
 - For State Energy Programs, requirements set forth in 10 C.F.R. § 420
- Cost share derived from the DOE loan program
- Revenues or royalties from the prospective operation of an activity beyond the project period
- Proceeds from the prospective sale of an asset of an activity
- Federal funding or property (e.g., Federal grants, equipment owned by the Federal Government)
- Expenditures that were reimbursed under a separate Federal program
- Cash or in-kind contributions used to meet cost share requirements for another Federal project or program
- Existing data as an in-kind contribution (e.g., data owned by an entity that is not routinely sold commercially but is instead donated to the project and assigned a value)

D. FFRDC Eligibility Criteria

1. DOE and Non-DOE FFRDCs as a Subrecipient

As long as no conflict exists, DOE (with the exception of NETL) and non-DOE FFRDCs may be proposed as subrecipients on another entity's application subject to the following guidelines.

Authorization for non-DOE FFRDCs

The Federal agency sponsoring the FFRDC must authorize in writing the FFRDC's participation on the proposed project, and you must submit this authorization with the application. The FFRDC's use must be consistent with its authority under its award.

Authorization for DOE FFRDCs

The Cognizant Contracting Officer for the FFRDC must authorize in writing the FFRDC participation on the proposed project, and you must submit this authorization prior to any award. The FFRDC's use must be consistent with the contractor's authority under its award.

Funding, Cost Share, and Sub-award with FFRDCs

The recipient and FFRDC must enter into an appropriate sub-award agreement that will govern, among other things, how the recipient funds the FFRDC portion of the work under its DOE award. This agreement must be fully executed before the FFRDC starts work directly related to the financial assistance award. The DOE funding office will fund the DOE FFRDC or non-DOE FFRDC participating as a sub-awardee under the DOE financial assistance award to the recipient.

The applicant should prepare the budgets using rates appropriate for funding the FFRDCs through sub-awards.

Responsibility

The recipient is the responsible authority for settling and satisfying all contractual and administrative issues, including but not limited to disputes and claims arising out of any agreement between the recipient and the FFRDC.

Limit on FFRDC Effort

The FFRDC effort, in aggregate, must not exceed 25% of the total project cost.⁴

⁴ Total project costs are the sum of the Government share, including FFRDC costs if applicable, and the recipient share of project costs.

III. Program Description

A. Program Purpose

The UTR program focuses on introducing students to the variety of research topics pursued in support of the HGEO mission and preparing them for jobs in related fields. The UTR program is HGEO's flagship program for funding workforce development and building research capacity at U.S. colleges and universities.

The UTR program provides resources to:

1. Expand the research capabilities and education of students in STEM;
2. Maintain and enhance the educational, training, and research capabilities of institutions of higher education; and
3. Develop education and training initiatives to support HGEO and DOE-wide priorities for R&D.

Additionally, the UTR program enables PIs at HBCUs, TCUs, and HSIs to competitively apply for funding in a restricted eligibility NOFO and facilitate student training in key R&D areas in preparation to enter the workforce.

This theme is consistent with the DOE Science Education Enhancement Act (42 U.S.C. § 7381) as amended by sections 1102 and 1105 of the Energy Policy Act of 2005, which provides the statutory authority for DOE initiatives. This theme is also consistent with The White House Initiative to Promote Excellence and Innovation at HBCUs (Executive Order 14283) by fostering more and better opportunities in higher education and improving the competitiveness of HBCUs for Federal R&D funding.

B. Program Goals and Objectives

This NOFO is looking for applications to educate and train the next generation of engineers and scientists to fill critical workforce gaps. This aim will be achieved by funding investigations pertinent to advancing the Administration's R&D goals. The funding aims to sustain a national university program of energy research and enable segments of the academic population not typically utilized for educational research opportunities for advancing competitive technology markets.

A technical description of the topic area is provided in the sections that follow.

C. Expected Performance Goals

Topic Area 1—This annual topic area seeks university-led R&D proposals focused on accelerating innovative energy technologies toward commercial viability, while simultaneously developing a skilled workforce for the evolving energy sector. Projects must include a non-academic partner to ensure research relevance and provide critical work experience for students.

D. Topic Area

1. Innovative Research and Training for Subsurface Energy Production

1.1 Background

DOE HGEO is dedicated to leveraging America's hydrocarbon and geothermal resources to ensure affordable, reliable, and secure energy.^{5,6} This mission is central to strengthening energy independence and leadership through innovation and cost-effective solutions that drive American prosperity.⁷ The UTR program is HGEO's primary initiative to cultivate the next generation of America's energy workforce. It achieves this goal by funding novel, early-stage R&D at U.S. IHEs, equipping students with cutting-edge, translatable skillsets.

To execute this mission with focused impact, HGEO has organized its Office of Subsurface Energy to represent three key energy sources: Coal, Oil & Gas, and Geothermal. This structure aims to support integrated research and technology solutions for the energy sector. This topic area is designed to solicit proposals that align directly with the strategic objectives of HGEO, fostering innovation within each research domain while upholding the core principles of the UTR program. Proposals should focus on early-stage, high-impact research that brings opportunities for student training and broader impacts to the technology market and the domestic energy workforce.^{8,9} The mandatory partnering organization will help to ensure the research project is guided by real-world market needs and will strengthen the career-readiness of students.

1.2 Objectives

This topic area seeks proposals for university-led R&D projects that align with HGEO R&D priority areas. These projects should foster the development of a skilled workforce prepared for careers in the energy sector. Projects must emphasize early-stage research with demonstrable potential for technology market impact within 5–10 years after successful completion of the UTR award. A letter of commitment from a partnering non-academic organization is a mandatory component of each proposal, with the partner actively contributing to the research direction, technology market applicability, student mentorship, and work experience.

Projects under this topic area will:

- Generate novel scientific and engineering breakthroughs that advance the technical readiness of promising energy technologies.
- Develop proof-of-concept demonstrations or laboratory-scale prototypes that validate scientific principles and demonstrate technical feasibility.
- Articulate a pathway for the transition of research outcomes to commercial applications, including potential market opportunities and scalability considerations.
- Address critical workforce skill gaps by integrating student participation directly into the R&D process and developing training modules that will have a lasting impact on student training beyond the awarded project.
- Foster strong collaboration with partnering non-academic organizations to ensure research relevance, facilitate technology transfer, and provide students with exposure to non-academic work environments and career paths.

1.3 *Research Scope and Prioritized R&D Initiatives*

Applicants must align their primary research focus with at least one of the following HGE Office of Subsurface Energy programs: Coal, Oil & Gas, or Geothermal. Priority initiatives within these offices may be modified in the future. Applicants are encouraged to check for future annual updates to this topic area, especially during a new submission period.

Applications that do not align with a priority initiative listed within one of the following three subtopics will be considered non-responsive and will not be reviewed or considered for selection.

1.3.1. TA 1—Subtopic 1A: Coal

- *Mining and Processing:*
 - Sensors for real-time monitoring or digital twins to enable timely operational changes and pathways for automation and remote operations.
 - Novel and efficient methods for extracting critical minerals and materials (CMM) and rare earth elements (REE), from coal-based byproducts.
- *Power and Capture:*
 - Development of advanced, cost-effective and scalable technologies for the management of water and co-products from existing coal-power plants (including coal combustion residuals, gypsum, zero-liquid discharge, etc.).

1. Thoroughness of the description of the proposed technology and degree to which the proposed technology or methodology meets the stated objectives of the topic area.
2. Degree to which the applicant comprehensively advances arguments and provides details that clearly distinguish the proposed R&D and why it is needed now relative to prior work.
3. Feasibility of the proposed concept; the degree to which the proposed work is based on sound scientific and engineering principles.
4. Degree to which the proposed technology is likely to demonstrate potential for technology market impact within 5 to 10 years after successful completion of the UTR award.

Merit Review Criterion 2: Technical Approach and Understanding (25%)

1. Adequacy and feasibility of the applicant's approach to achieving the objectives of the topic area and aligning with HGEO funding priorities.
2. Feasibility, appropriateness, rationale, and completeness of the proposed Statement of Project Objectives, such that there is a logical progression of work.
3. Demonstrated partnership with an applicable non-academic organization capable of advancing the technology with a strong commercialization pathway.
4. The adequacy and completeness of the Project Management Plan (PMP) in establishing baselines (technical scope, budget, schedule) and in managing project performance relative to those baselines; defining the actions that will be taken when these baselines must be revised; and identification of project risks and strategies for mitigation.

Merit Review Criterion 3: Strengthening the Energy Workforce (30%)

1. Degree to which students will be integrated into the project and how their R&D capabilities and work experience will be enhanced.
2. Demonstrated partnership with an applicable non-academic organization capable of leveraging the maturation and transition pathway of the developed technology to provide students with career growth and facilitate their entry into the workforce.
3. Likelihood of lasting impact or scalability of partnership for workforce development and/or student involvement.

Merit Review Criterion 4: Technical and Management Capabilities (20%)

1. Demonstrated experience of the applicant and partnering organizations in the technology areas addressed in the application and in managing projects of similar size, scope, and complexity.
2. Credentials, capabilities, and experience of key personnel and partnering organizations.
3. Clarity and likely effectiveness of the project organization, including subrecipients or partners, to successfully complete the project.
4. Adequacy and availability of proposed personnel, facilities, and equipment to perform project tasks.
5. Clarity and strength of commitment between proposed partners.

D. Other Selection Factors

In addition to the above criteria, the Selection Official may consider the following program policy factors to develop a broad portfolio of projects:

- The degree to which the proposed project exhibits technological diversity when compared with the existing DOE project portfolio and other projects selected from the subject NOFO

- The level of industry involvement and demonstrated ability to accelerate demonstration and commercialization and overcome key market barriers
- The degree to which the proposed project is likely to lead to increased high-quality employment and manufacturing in the United States
- The degree to which the proposed project will accelerate transformational technological advances in areas that industry by itself is not likely to undertake because of technical and financial uncertainty
- The degree to which the proposed project, or group of projects, represent a desired geographic distribution (considering past awards and current applications)
- The degree to which the proposed project will procure U.S. iron, steel, manufactured products, and construction materials
- The degree to which the proposed project demonstrably advances the President's policy priorities
